#### **Tuition:**

1-3 students 4<sup>th</sup> student (40% off) 5<sup>th</sup> student (90% off)

#### **Enrollment Fee:**

#### **Tuition Payment Plan Options:**

Grace Christian Academy offers two payment plan options. Payment plan option is to be declared at the time of enrollment.

- A. Pay-in-Full Option: Pay the full account balance directly to Grace Christian Academy by August 1st.
- B. **Monthly Payment Option:** The account balance is paid monthly August through May (10 monthly installments) via the FACTS Tuition Management Program. This option is an automatic payment plan made through your checking or savings account. Those choosing this option will complete a FACTS Agreement Form to authorize the automatic monthly payments on either the 5th or the 20th of each month. There is a yearly fee per family to set up payments with FACTS.
